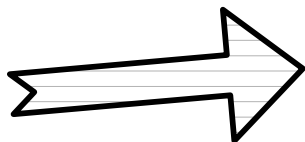

# ?? *What's Happening* ??

Every licensed taxi driver is a MEMBER of the London Taxi Association !!

Dear Members . . . . This letter is to inform you about something happening right now!

1. At the last General Meeting (Sunday April 22, 2012), the membership voted 100% in favor to proceed with filing an INJUNCTION against the City of London. Work has started. It will happen.
2. The INJUNCTION is to STOP the new taxi by-law to come into effect July 1, 2012.
3. The new by-law is very bad in many ways. It is hurtful and discriminates against taxicab drivers and plate owners. It favors and benefits the limousine industry. You will be hurt in many ways because you will become poorer, be ticketed more often, and possibly lose your licence and/or plate much easier.
4. Our lawyers from Siskinds the Law Firm are very good and they strongly feel the by-law is discriminatory against us and it should never become law. We only have a few weeks to stop it. Very soon, a judge in the Ontario Supreme Court will hear the reasons why an INJUNCTION is necessary. It will cost (up to) \$45,000 in fees. This is an important thing to do.
5. We have already collected \$10,000. We have \$35,000 to go. We collected over \$5,000 at the last meeting – and thank you for your help and your generosity. But we're not done yet.
6. We, the Board of Directors of the London Taxi Association determined that every plate owner needs to contribute \$200 per plate. We also ask that every driver voluntarily contribute at least \$20 to \$50 or more. Every dollar is very important to fight this unfair by-law.
7. BENEFITS to you:
  - We want limousines to stop playing the streets.
  - We want limousines to not take street hails (cannot pick up off the street)
  - We want limousine fares to increase to a level at least 15% higher than taxi.
  - We want City Hall to ENFORCE the cheating that limousines have been doing.  
(there are many more reasons and all benefit you)
